- Provide complete names, addresses, & phone numbers of references.
- State reason for leaving an employer and include explanations for any period of unemployment over 30 days during the work history.
- **Sign** the application.
- Additionally, federal law prohibits companies from hiring any persons unless valid documents establishing the person's identity and eligibility to work in the United States is provided. Providing the documents is a condition of employment.
- This application for employment does not imply a contract for employment.

- Jicarilla Apache Nation Ishkoteen Police Department- Records Check.
- Pre-employment drug testing and background check at Gaming Commission (JAGRC).
- All employees are required to obtain a gaming license. When an applicant is hired, the licensing agency, the JAGRC, will issue a temporary workers license while they process the permanent license. In order to obtain a permanent license, the Commission will conduct a background investigation of the employee according to the requirements set fourth by the National Indian Gaming Commission, Indian Gaming Regulatory Act, New Mexico State Compact, and all the rules and regulations of the Jicarilla Apache Nation.
- State issued Driver license or Identification, Social Security Card, CIB and a copy of High School Diploma or GED will be required for licensing.
